1. PURPOSE

The purpose of the Item is to request Council to declare the funeral of Jabulani "HHP" Tsambo a civic funeral.

2 BACKGROUND

Jabulani Tsambo was born on 14th September 1980 in Mahikeng in the North West Province. He passed away on 24 October 2018 at the age of 38, and was better known by his stage name Hip Hop Pantsula, later shortened to HHP, he was a South African Motswako rapper (Motswakorista) who performed in several languages, mostly in Setswana.

INTRODUCTION OF THE FINANCE ADMINISTRATOR AS PART OF THE PROVINCIAL INTERVENTION IN TERMS OF SECTION 137 OF THE MFMA IN THE NGAKA MODIRI MOLEMA DISTRICT MUNICIPALITY

1. PURPOSE

For the municipal council to note and accept the introduction of the Finance Administrator as part of the provincial intervention in terms of section 137 of the MFMA by the Department of Local Government and Human Settlements.

2. BACKGROUND

The Bokone Bophirima Provincial Executive Council resolved at its meeting held on the 22nd August 2018 to invoke provisions of Section 137 of the MFMA due to financial challenges prevalent in the Ngaka Modiri Molema District Municipality.

The planned intervention was brought to the attention of the municipal Council at its meeting held on 05th September 2018 where Council resolved (Resolution 91/2018) as follows: -

3. MOTIVATION

The Provincial Government through the Department of Local Government and Human Settlements has a legislative mandate to regularly monitor the performance and status of municipalities, provide support, build capacity, and intervene where it is necessary. The Department has identified financial management as the area in the Municipality where there is a need to intervene through other measures as there are evident signs of poor financial management in the Municipality, which negatively affect service delivery.

4. RECOMMENDATIONS

- c) That Mr Lefutswe shall be in charge of the Budget and Treasury Office and will report directly to the Accounting Officer
- c) That Mr Lefutswe be given the necessary support
